His first payment will be due one month from now. However, the mortgage has a 20-year balloon payment option, meaning that the balance of the loan could be paid off at the end of year 10. There were no other transaction costs or finance charges. How much will Mario's balloon payment be in 8 years?
- 23. The amount borrowed is the value of the restaurant times one minus the down payment, or:

Amount borrowed + € 200,000 (1 - 0.20) + €360,000

The monthly payments with a balloon payment loan are calculated assuming a longer amortization schedule, in this case, 20 years. The monthly return rate is:

$$r = 1.12^{100} - 1 = 0.0094$$

The payments based on a 20-year repayment schedule would be:
