Main duty of Executive Branch - Answer-to carry out or enforce our nation's laws--this means to put laws into action

Commander in Chief - Answer-The Constitution make the President the head of the nation's armed forces.

Chief Executive - Answer-The President enforces U.S. laws, creates policies, hires and fires officials within the executive branch, and appoints Federal judges. The Senate must approve many appointments, including Cabinet secretaries and Supreme Court Justices.

Chief Diplomat - Answer-The President can make treaties with other countries(although the Senate must approve them.) The President, working with the Secretary of State, shapes policies for dealing with other nations.
